Chief Information Security Officer

Information Technology (IT):
Computer systems that process, store and distribute data.

Cybercrime:
A crime that involves a computer, a network or the internet.

In today's world, more and more people use computers and digital tools to share their data online. Data is the new gold! So how do companies protect their data from malicious hackers and **cybercrime**? They hire a **Chief Information Security Officer**!

CHIEF INFORMATION SECURITY OFFICER

A **Chief Information Security Officer** or **CISO** is a company leader. The CISO is in charge of keeping critical information safe. This information could be in the form of paper files or digital data on a computer network. CISOs are responsible for protecting a company's **Information Technology (IT)**. They solve all of the information security issues that happen and make plans for the company to stay safe into the future.

How do CISOs help me?

Every time your family buys something online, uses a phone to bank, or uses a credit card at a store, they benefit from the work of a CISO. CISOs lead the teams that protect your family's personal information and data.

How do CISOs help the world?

Our world uses digital tools more and more. **Cybercrime** and **malicious hacking** are increasing. Any company that does business online is at risk. The CISO protects the company's **Information Technology** or **IT**.

What are some similar careers?

Chief Security Officers (CSOs) are similar to CISOs. However, they *only* work with a company's computer networks. They are responsible for physical and cyber security.

Chief Risk Officers are responsible for managing overall risk at the company, including cybersecurity.
